



INFORMATION REGARDING THE ASFINAG AUCTION 2020

CORONAVIRUS-related restrictions:

- Due to the current regulations in place for the protection of customers and employees, it is only possible for you to view the items in the marked area. We would like to make you aware that you will be escorted off the premises in the case of noncompliance.
- Viewing items is only possible on 07/10/2020 from 07:00 am to 4:00 pm and on 08/10/2020 from 07:00 am to 12:00 pm.
 Access for viewing items and collecting goods is only possible via the motorway junction A 8 Wels Wirtschaftspark! The reason for this is because the access road Albrechtstraße has been closed.

- You must disinfect your hands when you arrive at the ASFINAG premises. If you leave your own vehicle, you must wear a face mask without exception.
- An information sheet that includes a map will be handed out to you during your visit.
 We ask you to strictly follow the instructions on the information sheet, otherwise you will be escorted off the premises.
- It is not possible to access to the ASFINAG workshop and office buildings.
- If you have any questions about the process, there is an information point (see map).
 We ask for your understanding that more detailed questions about the items on display cannot be answered.
- A visitor toilet and disinfection stations are located on the premises (see map).
- Please present a valid ID document upon request as this is necessary for reasons of traceability.
- It is absolutely necessary to follow the orders of the security service, otherwise we
 would like to make you aware that you will be escorted off the premises in the case of
 non-compliance.

- Please remain seated in your vehicle as much as possible during the viewing. Of
 course, you may also take a closer look at selected items on display, but please
 make sure to keep the necessary distance and pay special attention to the hygiene
 regulations.
- We ask for your understanding that the items on display will remain locked during the entire viewing and cannot be opened.
- The auction will be taking place as an online auction exclusively on the Dorotheum website (www.dorotheum-fahrzeuge.com).
- You have to register once in order to place a bid. Please carry out this registration as soon as possible, as it takes time to activate your account.
- Payment is possible either by bank transfer or cash at the Dorotheum Traun auction house. Payment is not possible directly upon collection.
- When collecting your items, you will need the handover ticket, which you will receive after the Dorotheum has been paid in full. You may only collect your items in Wels after making an appointment in advance by email (wolfgang.doplbaur@asfinag.at). Your collection time will be confirmed to you by email. It is not possible to collect your items without an appointment as only a limited number of people may be on the premises at once due to the coronavirus protection measures. You can request an appointment Monday to Thursday between 7:00 am and 3:00 pm.
- Collection times must be agreed by email by 27/10/2020 at the latest.
- When making an appointment by email, the collection voucher must be enclosed and the person commissioned to collect the goods must be named (forwarding agent or at the very least the ID of the person collecting the items).
- If an appointment is not made by email for the items to be collected, then any legal claim to the goods becomes void in case of a missing collection voucher or if you have failed to name the person collecting the items, as well as in the case of noncompliance with the hygiene regulations. In these cases, people collecting the items will be escorted off the premises.
- Buyers undertake to inform the persons collecting the items of the stated specifications.
